## Aim of the EPLC

This course leads to the required qualification for European patent attorneys (who are entitled to act as professional representatives before the EPO in accordance with Article 134 EPC) to represent parties before the Unified Patent Court according to Article 48 AUPC.

The EPLC is designed specifically for legal practitioners and interested parties wishing to litigate before the UPC, particularly European Patent Attorneys.

Almost half of the course will be organised online. Participants can work using their own devices at home or in their offices. This is complemented by three short stays in Trier, during which participants will undergo intensive face-to-face training comprising interactive and practical exercises.

After successful online and oral examinations, the participating European patent attorneys will be granted the EPLC entitling them to represent parties before the UPC.

## About the partnership

The Academy of European Law (ERA) and Maastricht University (UM) joined forces in 2022 to create a dynamic and comprehensive training programme for Europeanpatent attorneys wishing to plead before the Unified Patent Court (UPC).

This collaboration was launched alongside the entry into force of the Protocol on Provisional Application of the UPC Agreement on 19 January 2022 – an event that marked the official establishment of the UPC as an international organisation.

With ERA's expertise in EU law training and UM's reputation as a leading international university, this high-calibre course equips European patent attorneys and professionals interested in patent litigation with the best tools to understand the legal framework and procedural rules necessary to litigate before the UPC.





## **Terms & Conditions**

#### **Participation**

According to Article 48 UPCA, to be able to represent a party before the Court, the patent attorney should first of all be entitled to act as a professional representative before the European Patent Office in accordance with Article 134 EPC. Proof of this entitlement is therefore requested from participants wishing to obtain the EPLC.

Legal practitioners with knowledge and experience in patent law and litigation may be accepted on the basis of a proven track record.

#### **Travel & Accommodation**

Participants organise their own travel and accommodation.

#### Language

Participants should have a working knowledge of English.

#### Costs

Participation fee: € 4200

This does not include travel or accommodation.

# Qualification for Representation before the Unified Patent Court

The course qualifies European patent attorneys, in accordance with Article 48 of the Agreement on a Unified Patent Court (AUPC), to represent parties before the Unified Patent Court (UPC).

#### **Specialised Training for Patent Attorneys**

The EPLC is specifically designed for European patent attorneys, providing in-depth knowledge of the legal framework and procedural rules of the UPC.

#### **Recognised Accreditation**

This EPLC programme is officially accredited by the Administrative Committee of the UPC.

#### **Interactive Case Studies & Moot Courts**

Practical case analyses and simulated court hearings create a realistic training experience organised in small groups.

#### Flexible Learning Structure

Approximately half of the course is conducted online, allowing participants to learn conveniently from home or the office. Monthly two-hour online tutorials are organised after working hours. This is complemented by three on site sessions in Trier, featuring intensive, interactive exercises.

As this course is centred on litigation practice before the UPC, on request and subject to verification, participation is also open to lawyers in private practice wishing to litigate before the UPC.

This course offers a varied social programme including networking dinners with fellow participants, winetasting in the Mosel vineyards, and a guided walking tour in the historic city centre of Trier, the oldest city in Germany, known for its well-preserved Roman and medieval architecture.
